### ARTICLEI

The name of the Corporation is:

PETS & VETS, PA.

### ARTICLE II

The purposes of the Corporation are:

- (a) To engage in the practice of veterinary medicine to render professional veterinarian services and to own and operate offices for the purpose of providing such services.
- (b) To own real and personal property, enter into contract and engage in any lawful business necessary to conduct a veterinary medicine practice and render professional veterinarian services.
