ARTICLES OF INCORPORATION OF W S R R INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of incorporation for such corporation:

ARTICLE I - NAME. The name of this corporation is $\mathbf{W} \ \mathbf{S} \ \mathbf{R} \ \mathbf{R}$

ARTICLE II - DURATION. This Corporation shall have perpetual existence unless dissolved according to law.
