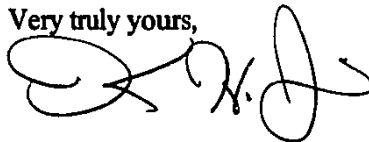

The name of this Corporation is: TCP, Corporation

**Article II - Duration**

This Corporation has perpetual existence.

The power to adopt , alter , amend, or repeal by-laws shall be vested in the Board of Directors, and the shareholders.

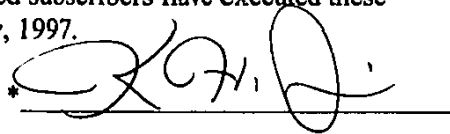
Article X - Indemnification

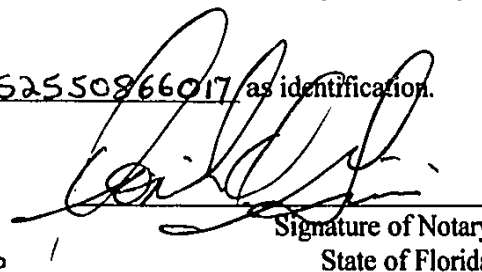
