ARTICLE I - NAME AND PRINCIPAL ADDRESS

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The name of the corporation is Belleair Oaks Office Center, Inc. and the principal address and principal place of business is 18167 US Hwy. 19 North, Suite 150, Clearwater, Florida 34624.

ARTICLE II - REGISTERED OFFICE AND AGENT
