ARTICLE I

The name of the Corporation is "AIRCRAFT FLIGHTLINE SUPPORT, INC."

ARTICLE II

Duration: The term of the existence of the corporation is perpetual.

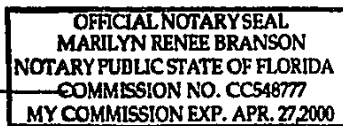
