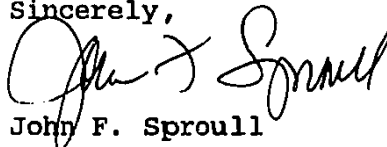

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of the Corporation shall be WEED HAWK,

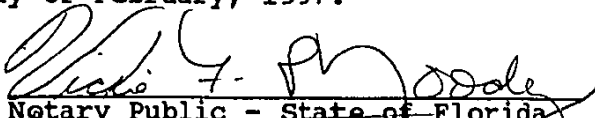
