ARTICLE I.

NAME

The name of this corporation is Summercorp, Inc.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of February 17, 1997.

BYLAWS

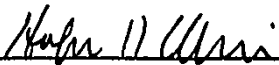

IN WITNESS WHEREOF, the undersigned executes these Articles of Incorporation this 17 day of February, 1997.

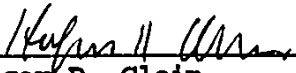
