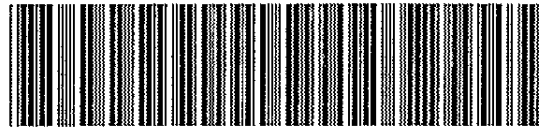

in the corporation) I gave it to them

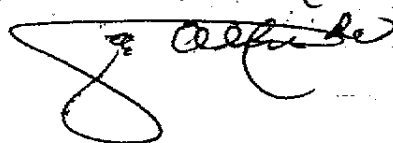
This occurred in Dec 01

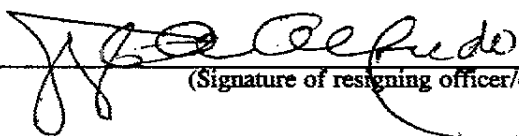
