The undersigned, acting as the incorporator of a corporation under the Florida Business Corporation Act adopts the following Articles of Incorporation for such corporation:

EFFECTIVE DATE 1/1/97

ARTICLE I NAME

The name of the corporation is Parrish Masonry, Inc.

ARTICLE II COMMENCEMENT AND DURATION OF CORPORATE EXISTENCE

Corporate existence shall commence on February 12, 1997 and shall exist perpetually thereafter until dissolved according to law.


