The undersigned, acting as the subscriber of a corporation under the Florida Corporation Law, adopts the following Articles of Incorporation for such corporation:

1.

Name

The name of the corporation is:





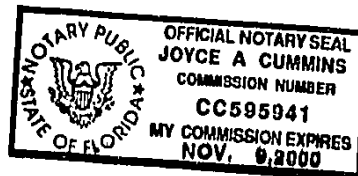
