

**ARTICLES OF INCORPORATION  
OF  
DATA FACTORY, INC.**

The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a Florida corporation ("corporation"), pursuant to Chapter 607, Florida Statutes.

**ARTICLE I**

**NAME:** The name of this corporation shall be "Data Factory, Inc."

**ARTICLE II**

**STREET ADDRESS:** The street address of the principal office of this corporation is 114 Canal Street, Suite G, New Smyrna Beach, FL 32168.

**MAILING ADDRESS:** The mailing address for this corporation is 114 Canal Street, Suite G, New Smyrna Beach, FL 32168.

**ARTICLE III**

**NATURE OF BUSINESS:** This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV**

**CAPITAL STOCK:** This corporation is authorized to issue 100 shares of common stock at a value of \$1.00 per share. The issuance and transfer of the corporation's stock shall be in accordance with Chapter 607, Florida Statutes.
