property or any interest therein, wherever situated;

(e) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets;

(f) To lend money to, and use its credit to assist, its officers and employees in accordance with Florida Statute \$607.141:
