## ARTICLES OF INCORPORATION

OF

Valle Coordination Services, Inc.



The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "Corporation") is Valle Coordination Services, Inc.

SECOND: The address, wherever located, of the principal office of the Corporation, if known, is 17703 Emerald Green Place, Tampa, Florida 33647.

THIRD: The mailing address, wherever located, of the Corporation is 17703 Emerald Green Place, Tampa, Florida 33647.

FOURTH: The number of shares that the Corporation is authorized to issue is 1,000, all of which are of a par value of \$1.00 each and are of the same class and are to be Common shares.

FIFTH: The street address of the initial registered office of the Corporation in the State of Fiorida is 17703 Emerald Green Place, Tampa, Florida 33647.

NINTH: Whenever the Corporation shall be engaged in the business of exploiting natural resources or other wasting assets, distributions may be paid in cash out of depletion or similar reserves at the discretion of the Board of Directors and in conformity with the provisions of the Florida Business Corporation Act.
