

ARTICLES OF INCORPORATION OF



Ascensions Enterprises, Inc.

ARTICLE 1. - NAME

The name of the Corporation is Ascensions Enterprises, Inc.

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the Corporation shall initially be at 125 First Ave., Nokomis, FL 34275. The Corporation may change its principal office from time to time as permitted by law.

ARTICLE 3. - MAILING ADDRESS

The initial mailing address of the Corporation shall be 125 First Ave., Nokomis, FL 34275. The Corporation may change its mailing address from time to time as permitted by law.

ARTICLE 4. - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE 5. - POWERS

This Corporation shall have all of the powers enumerated in the Florida General Corporation Act.

ARTICLE 6. - SHARES (CAPITAL STOCK)

the common stock of the Corporation as may be issued from time to time over and above the issue of the first shares of the common stock of the Corporation which have never previously been sold or issued.
