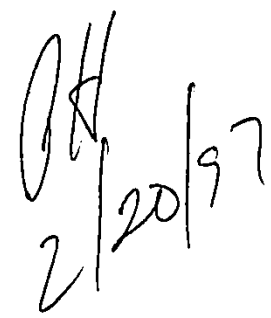

ARTICLE I - NAME

The name of this Corporation shall be LR GRAPHICS, INC.

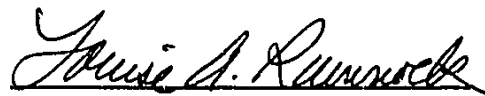

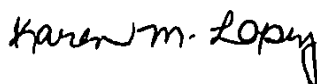
