ARTICLES OF INCORPORATION
OF

ARTICLE I
NAME

The name of the corporation shall be CRESTVIEW SKYDIVING

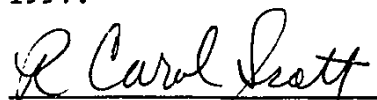

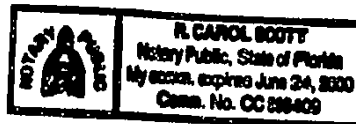
