# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WHEELER MOTORSPORTS, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation hereby amendes its Articles of Incorporation for purposes of increasing the number of shares of stock outstanding, as follows:

I.

The present ARTICLE III, CAPITAL STOCK, is hereby deleted, and the following new ARTICLE III, CAPITAL STOCK, is hereby inserted in lieu thereof:

# "ARTICLE III.

# CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to have issued and outstanding at any one time shall be:

- (a) Ten Thousand (10,000) shares of One Dollar (\$1.00) par value voting common capital stock; and
- (b) Ten Thousand (10,000) shares of One Dollar (\$1.00) par value non-voting common capital stock.

There shall not, except for voting rights as aforesaid, be any distinctions or differences in the rights, privileges and preferences of such stock."

The effective date of this Amendment shall be October 27, 1999.
