**ARTICLES OF INCORPORATION
OF
WEBSTER COATINGS, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts these the following Articles of Incorporation:

ARTICLE I NAME

The name of this corporation is Webster Coatings, Inc.

ARTICLE II DURATION

This corporation is to exist perpetually pursuant to Florida Statutes.

ARTICLE III PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States of America or the State of Florida.

ARTICLE IV. SHARES

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Hundred (100) shares, having nominal or par value of one Dollar (\$1.00) per share.

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon sale for cash of any new stock of this corporation of the same in, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI INITIAL REGISTERED AGENT AND STREET ADDRESS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

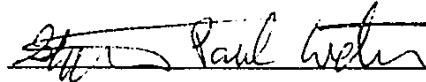
ARTICLE XI. ACTION BY DIRECTORS WITHOUT A MEETING

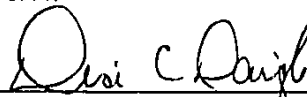

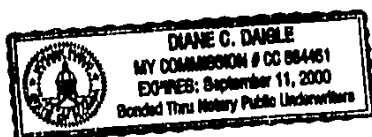

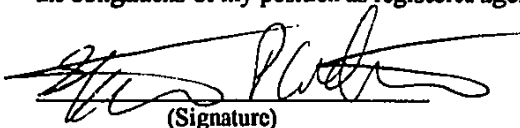
