

3. That simultaneously herewith, he is filing Articles of Incorporation for a new corporation, also to be known as WEST FLORIDA PLASTERING, INC.



The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I: NAME AND PRINCIPAL OFFICE ADDRESS**

The name of this corporation is WEST FLORIDA PLASTERING, INC., and its principal office address is 9311 Gulf Beach Highway, Pensacola, Florida 32507

**ARTICLE II: DURATION**

This corporation shall exist perpetually, commencing March 1, 1997.

**ARTICLE III: PURPOSE**

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV: CAPITAL STOCK**

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, all of one class and series. The whole or any part of the authorized shares of the corporation may be issued for a consideration payable in
