This corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is AIM HIGH PRODUCTIONS, INC.
2. The text of the amendment as adopted is as follows:

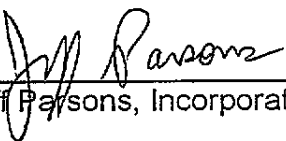
ARTICLE IV

This corporation is authorized to issue 1,000,000 shares of common stock, which shares shall be issued as fully paid and non-assessable. The stock of this corporation shall be so assigned, issued and transferred only in accordance with such By-laws as the corporation shall from time to time make, change or alter with a lien reserved in favor of the corporation, upon all of its capital stock for any indebtedness which may at any time be due by the holder of the same unto the corporation.

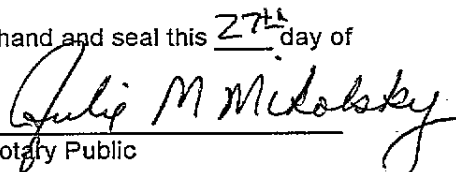
