Because of the similarities between the existing corporation and the one you are now seeking to file with us, and because it is our duty to assure that all fees due this office in accordance with section 607.0130(2)(c), Florida Statutes, are collected, we are returning the articles of incorporation unfiled and must request you return the existing corporation to good standing by completing the enclosed reinstatement application and submitting it with the appropriate fees.


Dear Ms. Poole,

Thank you for your letter of December 30, 1996 (copy enclosed) regarding the above referenced matter. Dr. Watson filed a "final tax return" on 10/02/92 that was accepted by the Internal Revenue Service. Thus we cannot reinstate this Corporation. A copy of same is enclosed for your perusal. Dr. Watson was unaware that a separate "Dissolution of Corporation" request, along with \$35.00 had to be filed with your department to properly terminate this entity in Florida as he completed his own taxes.
