ARTICLES OF INCORPORATION

OF

CLASSIC SECURITY, INC.



- I, the undersigned, being a natural person of legal age, do hereby desire to form a Corporation under the Laws of the State of Florida, and do hereby adopt the following Articles of Incorporation:
- 1. **NAME.** The name of the Corporation shall be CLASSIC SECURITY, INC., a Florida Corporation.
