**ARTICLES OF INCORPORATION
OF
CAROLINA FLORIDA PROPERTIES AF#2, INC.**

(a Florida corporation)

THE UNDERSIGNED, acting as sole incorporator of **CAROLINA FLORIDA PROPERTIES AF#2, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

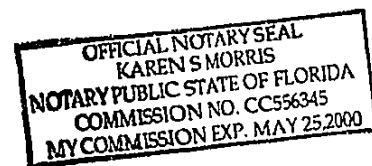


**ACCEPTANCE OF APPOINTMENT
