In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a resident of the State of Florida of full age, does hereby certify:

I. **CORPORATE NAME:** The name of the corporation is: ~~TEKO, INC.~~ TEPEKO, INC.

II. **PURPOSE:** The purpose of this corporation shall be to participate in all such activities as may be allowed by law.

III. **DURATION:** The duration of the corporation is perpetual.
