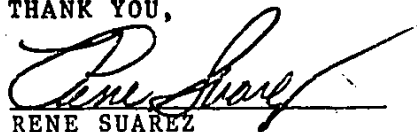

ARTICLE I

NAME

The name of this corporation is : COLLOSSUS INCORPORATED

ARTICLE II

NATURE OF BUSINESS

This corporation is being formed for the following purposes;

ARTICLE VII

CLASSES OF DIRECTORS

The expenses, including the cost of any judgment, fines settlements and counsel fees actually and necessarily paid or incurred in connection with any action suit or processing whether civil criminal, administrative or investigative, and any appeal thereof, to which any such person or his legal representative maybe made a party by reason of his being or having been a director, officer, employee or agent as here in provided. The forego right of indemnification shall not be exclusive of any other rights to which any directors, officer, employee or agent may be entitled as a matter of law he may be lawfully granted.
