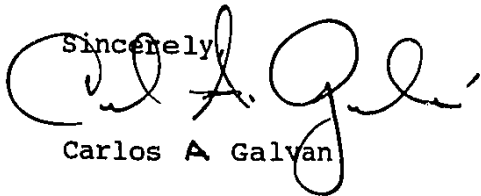

ARTICLES OF INCORPORATION

OF

GALCAR, CORP.

The undersigned natural person acting as incorporator of a corporation under the provisions of the Florida General Corporation Act, hereby adopts the following ARTICLES OF INCORPORATION:

**ARTICLE I
NAME OF THE CORPORATION**

The name of the Corporation is: GALCAR, CORP.

**ARTICLE II
DURATION**

The period of duration of the Corporation is: Perpetual

**ARTICLE III
NATURE OF BUSINESS**

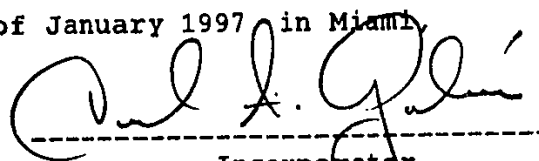

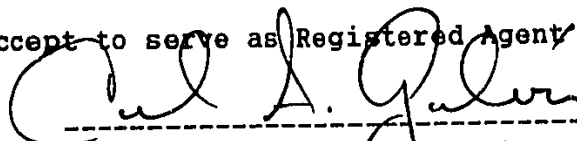
