Article I - Name

The name of this corporation is **ECO-PRIDE EXTERMINATING, INC.**

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business, including, but not limited to, operating, conducting, and providing services related to insecticide and pest control treatments, inspections, repairs, replacements, including, but not limited to termites and other wood-destroying organisms, and any business related thereto for which corporations may be incorporated under the provisions of the Florida General Corporation Act.

Article IV - Capital Stock


