The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby associate himself (themselves) to form a Corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is: REELIZATION , INC.

ARTICLE II

PURPOSES

RT
The general nature of the business to be transacted by this corporation are: The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

CAPITAL STOCK

The capital stock of this corporation shall be SEVEN THOUSAND FIVE HUNDRED & 00/100 (\$7,500.00) dollars represented by seven hundred fifty (750) shares of TEN & 00/100 (\$10.00) dollars each.

This stock shall have full voting rights, preemptive privileges, noncumulative as to dividends, and shall be issued fully paid and non-assessable.

The stock shall be restricted as to transfer as follows: This stock may not be transferred on the books of this corporation without first giving the right of purchase for TWENTY (20) days to the corporation at the book value of the stock, and thereafter for TEN (10) days to any stockholder of record, at the same price and terms of any bonafide offer which the holder may desire to accept.

All of said stock shall be payable in cash, equipment, property real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this corporation.

ARTICLE IV

INITIAL CAPITAL

ARTICLE V

TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI

DIRECTORS

This corporation shall have (ONE) Director(s) initially. The number of Directors may be increased at times by vote of the stockholders as the By-Laws direct.
