ARTICLE ONE

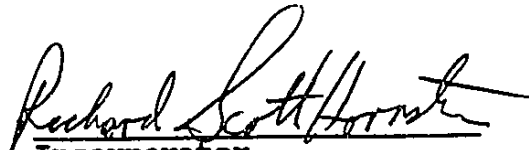
