#### ARTICLE I - NAME

The name of this corporation is GOOD STUFF CHEAP, INC. 971 E. Plant Street, Winter Garden, Florida 34787 ARTICLE II - DURATION

This corporation shall have perpetual existance commencing on the date of this filing of these Articales with the Department of State.
