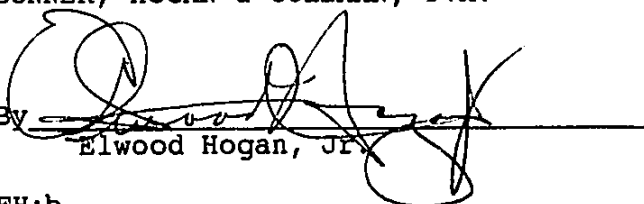

Name

The name of this corporation is J & B HOLLINS, INC.

ARTICLE II

Duration

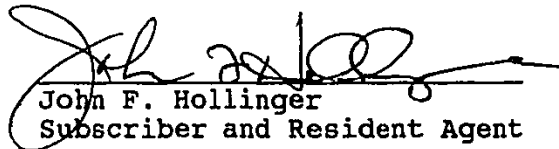
