

ARTICLES OF INCORPORATION

of

ROBERT BRUCE WALKER, P.A.

The undersigned incorporator and subscriber to these Articles of Incorporation, being duly licensed to engage in the profession of Realtor Associate under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I - NAME

The name of the professional service corporation is ROBERT BRUCE WALKER, P.A.

ARTICLE II - PURPOSE

The professional service corporation is formed to engage in every phase of the profession of Realtor Associate. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds or any other type of investment, and own real and personal property necessary for rendering of professional services.

ARTICLE III - TERM OF EXISTENCE

The professional service corporation shall have perpetual existence commencing on the date these Articles of Incorporation are filed with the Department of State of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The capital stock of the professional service corporation shall be One Hundred (100) shares of common stock having a par value of One (\$1.00) Dollar per share. These shares shall have unlimited voting rights and are entitled to receive the net assets of the corporation upon dissolution.
