Gentlemen:

I was very surprised to have learned that my corporation was dissolved by your office effective October 16, 1998 through the enclosed Application of Reinstatement.

According to your office, there was one annual report sent to me in early February/late March. This Application of Reinstatement was the first and only document from your office. I have not received any others. I would also like to point out that I did have problems with my neighborhood's postal service between January and September. My credit card statements and utilities bills were nowhere to be found either. I have to call up for my balances in order to pay my bills. Your report was not one of the normal "bills" I am used to receiving and I have no idea that this had to be paid by a certain dead line.

In view of the above explanation, I enclose my check for \$150 being full payment without the reinstatement fee. I did not intentionally ignore any mails from you and ask that you accept my check and not to dissolve my corporation. Please also understand that I just started this corporation a year ago and the additional \$600 will put me into jeopardy. Should you not be able to do that, please return the said check; I will have no choice but to be forced to dissolve my company.
