ARTICLES OF INCORPORATION

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be:
PRIMELAB, INC.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The aggregate number of shares which the corporation is authorized to issue is One Million shares of Common Stock at par value of twenty-five cents (\$0.25) per share. The initial issue shall be limited to One Thousand shares. All shares of the initial issue are subject to the terms of a pre-incorporation agreement dated February 15, 1997 which shall be made a part of the By-Laws to be adopted. That Agreement prohibits transfer or incumbrance of any shares except pursuant to its terms. It also prohibits issuance of any further shares without approval of the persons who hold at least 75% of all issued and outstanding shares.

ARTICLE IV

The street address of the initial registered office of the corporation is 500 Australian Avenue South, Suite 600, West Palm Beach, Florida 33401 and the name of its initial registered agent at such address is Joseph K. Still, Jr. The principal office and mailing address of the corporation is P. O. Box 12277, Lake Park, Florida 33403.


