

### ARTICLES OF INCORPORATION

**OF** 

#### ENDLESS DESTINATIONS BY LISA, INC.



The undersigned incorporator, Lisa Kennedy, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

#### **ARTICLE I - NAME**

The name of this corporation is ENDLESS DESTINATIONS BY LISA, INC.

#### ARTICLE II - PRINCIPAL OFFICE

#### **ARTICLE III - PURPOSE**
