

ARTICLES OF INCORPORATION  
OF

ARTICLE I

The name of this Corporation is: Clean In Motion West, Inc.

This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes.

This Corporation is authorized to issue 1,000 shares of common stock, no par value.

corporation, and each and every person who may become a director of this Corporation is hereby relieved from any liability that might otherwise exist from thus contracting with this Corporation for the benefit of himself or any firm, association or corporation in which he may be anywise interested. Any director of this Corporation may vote upon any contract or other transaction between this Corporation and any firm, association or corporation in which he may be anywise interested.


