

ARTICLES OF INCORPORATION

27/20 / 1 The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation for profit under Chapter 607 of the Florida Statutes, as amended.

ARTICLE I - NAME

The name of this corporation shall be: Evia Foods Inc.

ARTICLE II - INITIAL PRINCIPAL OFFICE
