THE UNDERSIGNED, being of legal age and a natural person, does' hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

FIRST: The name of this corporation shall be:

WARNIR, INC.

<u>SECOND</u>: This corporation shall commence its existence on February 13, 1997, that date being the date of subscription to these Articles of Incorporation and this corporation shall exist perpetually thereafter unless sooner dissolved according to law.
