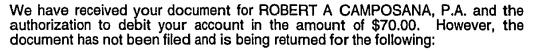

ARTICLES OF INCORPORATION OF ROBERT A. CAMPOSANO, P.A. A PROFESSIONAL CORPORATION

The undersigned, who is duly licensed to practice real estate in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation:

ARTICLE ONE NAME

The name of the Corporation shall be ROBERT A. CAMPOSANO, P.A.

ARTICLE TWO REGISTERED OFFICE AND AGENT

The location and address of the Corporation's initial registered office in Florida is 995 North Collier Boulevard, Marco Island, Collier County, Florida 34145. The initial registered agent at the registered office is John A. Nold, P.A. who upon accepting this designation agrees to comply with the provisions of Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process. The principal office of this corporation is 568 Tigertail Court, Marco Island, Florida 34145.

ARTICLE THREE PURPOSE
