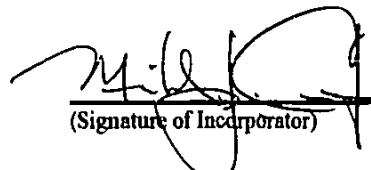

- FIRST. The name of the Corporation is Builders Export, Incorporated.
- SECOND. Its registered office is in the State of Florida, and its principal offices of business are the same and is to be located at 5856 SW 15th Street, in the City of Miami, County of Dade. The registered agent in charge thereof is *Michael J. Courtney*, at the same address, above.
- THIRD. The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as natural persons might or could do, in any part of the world, viz:
- "The purpose of the corporation is to engage in any lawful act or activity for which the corporations may be organized under the general Corporation Law of Florida."
- FOURTH. The corporation shall have the authority to issue 100 shares of common stock, each share to have no Par Value. The shares may be issued for the consideration expressed in dollars as may be fixed from time to time by the Board of Directors.
