V A. Business Intent

V B. Management and Administration

V C. Powers of the Corporation

V D. Par Value of Shares and Percentages

The Par Value of Shares will be \$25.00 The Value of the Shares of Stock shall be re-evaluated and assigned an updated value each and every year. This shall be done in the last quarter of the calendar year, at the quarterly meeting of the Corporate Officers and recorded in the Corporate minutes.

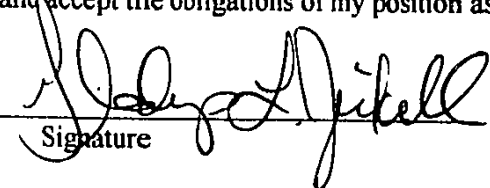
