ARTICLES OF INCORPORATION MORTON KOSTO, P.A.

STATE OF FLORIDA COUNTY OF SEMINOLE

We, the undersigned, hereby associate ourselves together for the purpose of becoming a professional association (hereinafter "corporation") under and by virtue of the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a professional associations and corporations for profit.

ARTICLE I

The name of the corporation shall be: MORTON KOSTO, P.A.

ARTICLE II

The objects and purposes of the corporation and the general nature of the business or businesses to be transacted shall be as follows:

- 1. To engage in the business of providing legal services.
- 2. To engage in all other lawful businesses.
- To make and enter into all contracts necessary and proper for the conduct of its business or businesses.
- 4. To borrow money of any person, firm or corporation, to issue bonds, debentures, or obligations of this corporation from time to time for any of the object or purposes of the corporation and to secure same by mortgage, pledge or by any other lawful means.

To do any and all things necessary, suitable and proper for the accomplishment of any of the purposes or for the attainment of any of the objects or for the exercise of any of the powers herein set forth, whether herein specified or not, either along or in connection with other firms, individuals or corporations, whether in the State of Florida or throughout the United States or elsewhere, and to do any other act or acts, thing or things incidental or pertinent to or connected with the businesses hereinbefore described, or any part or parts thereof, if not inconsistent with the Laws of the State of Florida.
- 7. In general, this professional association shall have and exercise all the powers conferred by the Laws of the State of Florida upon corporations for profit. It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

ARTICLE III

The professional association shall have perpetual existence.

ARTICLE IV

The address of the principal office of the professional association shall be 518 Spring Club Drive, Altamonte Springs, Florida 32714.

ARTICLE V

The capital stock of the corporation shall consist of 5,000 shares of common stock with a \$1.00 par value.

ARTICLE VI

The amount of capital with which the corporation shall commence business shall not be less than \$500.00.

ARTICLE IX
