as follows:

The aggregate of shares of stock of said corporation shall be 50 shares of common stock with a par value of \$100.00.

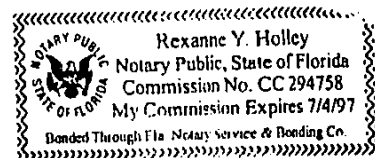
