ARTICLE VI



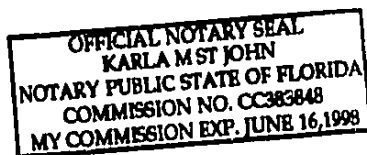
