ARTICLE VI



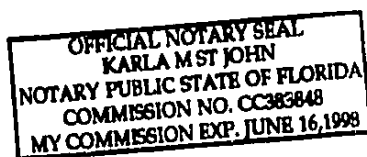
