On March 27, 1999, Mr. Barry Rosenfield received check #1115 to prepare the corporation annual report with appropriate documents from your office. He did enter and sign his name as the new registered agent for this corporation, but never sent the documents, nor the check to your office. Instead, he put HIS name on the check and cashed the amount of \$300.00.

On April 26, 1999, we discovered that Mr. Barry Rosenfield was a convicted felon with 29 offenses of grand theft fraud. (see attached files). Needless to say, as of April 27, 1999, Mr. Barry M. Rosenfield was fired from this company. Approximately 40 other pieces of mail and legal correspondence, of this corporation, was found in his vehicle, not mailed.

Now, on October 1, 1999, our insurance broker faxed to us information about "administrative dissolution for annual report" effective 9-24-99. If it were not for this fax from the insurance broker, we would've had no idea that Mr. Barry Rosenfield did not file the "annual report" and pocketed the money among the other money that we discovered.

Now, looking at this situation of being the victim of a convicted felon, I'm now asking you to please waive the reinstatement fees, and to allow us to only pay the original \$150.00 filing fee. We, at Second Choice, Inc. want to keep our company name clean and



not to be penalized for acts of a convicted felon. I believe that we have suffered more than enough by his acts.
