The undersigned person, David King, whose post office address is 1506 East Ridgewood Street, Orlando, Florida, 32803, being of full legal age, hereby under and by virtue of the General Corporation Law of the State of Florida is acting as Incorporator in the formation of the below referenced corporation:

ARTICLE ONE The name of the corporation is RADIO UNLIMITED, INC.
