ARTICLE I

Name

The name of this corporation is INTEGRATED MARKETING AND SALES, INC.

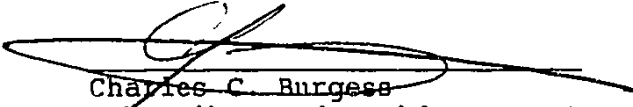
