

ARTICLES OF INCORPORATION OF OMAL, INC.



ARTICLE I - NAME

The name of this Corporation is OMAL, INC. and its address is c/o MAS, 201 S. Biscayne Boulevard, 1500 Miami Center, Miami, FL 33131.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.
