ARTICLES OF INCORPORATION  
OF

SURFSIDE BEACH SERVICE AND WATER SPORTS, INC.

ARTICLE I.  
NAME

The name of the corporation shall be SURFSIDE BEACH SERVICE AND WATER SPORTS, INC.

ARTICLE II.  
PRINCIPAL OFFICE

DURATION

The duration of the corporation shall be perpetual.


